


A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE EXECUTIVE OFFICES-OFFICE OF ENTERPRISE ASSETS MANAGEMENT TO EXECUTE FC-6798 TEMPORARY SERVICE CONTRACTS FOR RETIRED ATLANTA POLICE DEPARTMENT OFFICERS (APD) WITH UP TO FORTY (40) RETIRED ATLANTA POLICE OFFICERS, FOR THE PURPOSE OF PROVIDING ENHANCED PROFESSIONAL SECURITY SERVICES AT CITY HALL, THE PUBLIC SAFETY HEADQUARTERS, AND THE PUBLIC SAFETY ANNEX, FOR A PERIOD OF TWO (2) YEARS, TO BE PAID IN YEARLY INCREMENTS OF EIGHT HUNDRED SEVEN THOUSAND, THREE HUNDRED THIRTY FIVE DOLLARS (\$807,335.00) BEGINNING IN FY2014, ALL EXPENSES TO BE CHARGED TO AND PAID FROM 1001 (GENERAL FUND), DEPARTMENT 040401 (EXE. GENERAL BUILDINGS), ACCOUNT 5212001 (CONSULTING/PROFESSIONAL) FUNCTION ACTIVITY 1565000 (GEN GOV BLDGS. & /PLANTS); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) has identified a need to enhance security at City Hall, the Public Safety Annex, and the Public Safety Headquarters (collectively the “Facilities”); and


WHEREAS, retired Atlanta police officers possess the knowledge, skills, abilities and expertise necessary to provide the desired enhanced security at the Facilities, including arresting powers; and

WHEREAS, the Office of Enterprise Assets Management (“OEAM”) desires to execute temporary service contracts with up to forty (40) retired Atlanta police officers, for the purpose of providing professional security services at the Facilities, for a period of two (2) years beginning in FY2014 in an amount not to exceed Eight Hundred Seven Thousand, Three Hundred Thirty Five Dollars (\$807,335.00); and

WHEREAS, one (1) Atlanta police officer shall be designated supervisor and shall be compensated at \$30.00 per hour and the remaining thirty-nine (39) Atlanta police officers shall be compensated at \$25.00 per hour; and

WHEREAS, these temporary service contracts are authorized pursuant to Article 3, Chapter 5, Section 3-505 of the Charter of the City of Atlanta.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is authorized to execute temporary service contracts, on behalf of OEAM for up to forty (40) retired Atlanta police officers where one (1) shall be designated supervisor and shall be compensated at \$30.00 per hour and the remaining thirty-nine (39) Atlanta police officers shall be compensated at \$25.00 per hour for security services at the Facilities for a period of two (2) years beginning in FY2014, in an



amount not to exceed Eight Hundred Seven Thousand, Three Hundred and Thirty-Five Dollars and Zero Cents (\$807,335.00) total.

BE IT FURTHER RESOLVED, that the City Attorney or her/his designee be and is directed to prepare the temporary service contracts for execution by the Mayor.

BE IT FURTHER RESOLVED, that the contracts shall not become binding on the City and the City will incur no obligation or liability under them until they have been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney, and delivered to the Atlanta police officers.

BE IT FINALLY RESOLVED that all expenses shall be charged to the following Fund, Department, Account and Function Activity numbers: 1001 (General Fund), Department 040401 (Exe. General Buildings), Account 5212001 (Consulting/Professional) Function Activity 1565000 (Gen Gov Bldgs. & /Plants).
