A RESOLUTION TO ESTABLISH THE DISTRICT 5 ATLANTA-IN-DEKALB POLICE JURISDICTION TASK FORCE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta and DeKalb County have independent 911 call centers and police departments

WHEREAS, residents of both the City of Atlanta and unincorporated DeKalb County have reportedly had their emergency calls being routed across jurisdictional boundaries and experienced slow emergency response times

WHEREAS, previous attempts to address this have not fully resolved the problem

WHEREAS, it is vital to public safety of Atlanta-in-DeKalb residents that 911 calls are routed properly and that emergency responders are dispatched quickly

WHEREAS, the safety of residents is of paramount importance to the City of Atlanta

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: The District 5 Atlanta-in-DeKalb Police Jurisdiction Task Force is hereby established.

Section 2: The Task Force shall consist of 12 members as follows:

Mayor or Designee

Atlanta City Council President or Designee

District 5 Councilmember Natalyn Archibong

DeKalb County Commissioner Larry Johnson

APD Chief of Police or Designee

DeKalb County Chief of Police or Designee

One Representative from Atlanta 911 Call Center

One Representative from DeKalb 911 Call Center

Section 3: The Task Force shall have at least three working sessions.

Section 4: The Task Force shall submit a report 90 days following the enactment of this resolution
