**AS SUBSTITUTED BY FINANCE/EXECUTIVE COMMITTEE**

**CORRECTING ORDINANCE NUMBER 13-O-1054 WHICH TRANSFERRED FUNDS FROM THE DISTRICT 5 COUNCILMEMBER'S CARRY-FORWARD ACCOUNT IN THE NON-DEPARTMENTAL RESERVES TO IDENTIFY THE CORRECT CITY DEPARTMENTS TO RECEIVE FUNDING IN THE CAPTION, THE 5<sup>TH</sup> WHEREAS, AND SECTION 1 OF THE LEGISLATION; AND FOR OTHER PURPOSES.**

**WHEREAS**, Ordinance Number 13-O-1054 was adopted by City Council August 19, 2013 and approved by Operation of Law per City Charter Section 2-403 on August 28, 2013; and

**WHEREAS**, the ordinance was introduced to transfer funds from District 5 Councilmember's Carry-Forward in the Non-Departmental Reserves to assist the Senior Summer Camp at Butler Park and the Atlanta Police Department for projects in District 5; and

**WHEREAS**, the legislation incorrectly states in the caption, the 5<sup>th</sup> WHEREAS, and Section 1 that the \$112,000.00 amount was to be contributed to the Department of Public Works instead of the Atlanta Police Department (\$48,000.00) and Department of Public Works (\$64,000.00); and

**WHEREAS**, the District 5 Councilmember and the Department of Public Works are in agreement with the correction being made to the legislation.

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA** as follows:

**SECTION 1:** That Ordinance 13-O-1054 (**See Attached**) is hereby amended to reflect the correct departments the \$112,000.00 is to be transferred to in the caption, the 5<sup>th</sup> WHEREAS, and Section 1 of the legislation.

**SECTION 2:** That all ordinances and parts of ordinances in conflict herewith be and are hereby waived.

**AUTHORIZING THE CONTRIBUTION OF FUNDS FROM THE DISTRICT 5 COUNCILMEMBER'S CARRY-FORWARD ACCOUNT IN THE NON-DEPARTMENTAL RESERVES BE CONTRIBUTED TO THE DEPARTMENT OF PARKS AND RECREATION FOR SENIOR SUMMER CAMP AT BUTLER PARK, IN THE AMOUNT OF \$500.00 AND TO THE ATLANTA POLICE DEPARTMENT (\$48,000.00) AND DEPARTMENT OF PUBLIC WORKS (\$64,000.00) TO FUND VARIOUS PROJECTS IN DISTRICT 5, IN THE AMOUNT OF \$112,000.00; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Senior Summer Camp at Butler Park provides activities to 75 to 100 senior citizens daily, participating in arts and crafts, computer classes and fitness activities; and

**WHEREAS**, part of the City's mission is to support the Community by providing cultural and entertainment options for all citizens, both youth and seniors; and

**WHEREAS**, the District 5 Councilmember wishes to contribute funds from that District Councilmember's Carry-Forward in the Non-Departmental Reserves to the Senior Summer Camp at Butler Park; and

**WHEREAS**, the donation will provide one hot meal, for each week for senior citizens participating; and

**WHEREAS**, the Councilmember also wishes to contribute funds from her Carry-Forward in the amount of \$112,000.00 to the Department of Public Works and Atlanta Police Department for projects in District 5 (Department of Public Works \$64,000.00 for digital speed limit signs and Atlanta Police Department \$48,000.00 for cameras to be integrated into the VIC System).

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS**, as follows:

**SECTION 1:** That the 2013 (General Fund) Budget be hereby amended as follows:
