**PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

**AN ORDINANCE, AMENDING THE 2013 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS, FIFTY THOUSAND DOLLARS (\$50,000) WITH NO MATCHING FUNDS, TO GRANT G12GA0003A, FROM THE WHITE HOUSE OFFICE OF NATIONAL DRUG CONTROL POLICY (“ONDCP”), FOR THE PURPOSE OF CONTINUING THE ATLANTA HIGH INTENSITY DRUG TRAFFICKING AREA TASK FORCE (“ATLANTA HITDA”), TO DISRUPT AND DISMANTLE DRUG TRAFFICKING ORGANIZATIONS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the White House Office of National Drug Control Policy (“ONDCP”) grants funding to High Intensity Drug Trafficking Area (“HIDTA”) program task forces responsible for disrupting and dismantling violent drug trafficking organizations; and

**WHEREAS**, the Department of Police (“Department”) has been a participant in the Atlanta High Intensity Drug Trafficking Area task force (“Atlanta HIDTA”) for over ten years; and

**WHEREAS**, as per Resolution 05-R-0680, the Atlanta Police Department (“Department”) acts as the “pass through agency” to disburse payments for task force expenses that are completely federally funded, and with no matching funds; and

**WHEREAS**, the ONDCP awarded the City grant G12GA0003A (“grant”), in the amount of five-million, one hundred eighty-one thousand, four-hundred eighty-one dollars (\$5,181,481), to continue funding the Atlanta HIDTA task force initiatives, and this award was subsequently approved by Council and the Mayor through ordinance 12-O-0667; and

**WHEREAS**, ONDCP modified grant award #G12GA0003A with modification #1, which added an additional six hundred ninety-five thousand dollars (\$695,000), bringing the grant award to a new total of five million, eight hundred seventy-six thousand, four hundred eighty-one dollars (\$5,876,481), with no matching funds, and this modification was approved by Council and the Mayor through ordinance 12-O-1569; and

**WHEREAS**, ONDCP further modified grant award #G12GA0003A with modification #2, which increased the award by forty-five thousand dollars (\$45,000), bringing the grant award to a new total of five million, nine hundred twenty-one thousand, four hundred eighty-one dollars (\$5,921,481), with no matching funds; and

**WHEREAS**, ONDCP further modified grant award #G12GA0003A with modification #3, which reduced the award by nine thousand, six hundred thirty-seven dollars (-\$9,637), bringing the grant award to a new total of five million, nine hundred eleven thousand, eight hundred forty-four dollars (\$5,911,844), with no matching funds; and



**WHEREAS**, ONDCP further modified grant award #G12GA0003A with modification #4, which increased the award by twenty-four thousand, one hundred eighty-four dollars and fifty cents (\$24,184.50), bringing the grant award to a new total of five million, nine hundred thirty-six thousand, twenty-eight dollars and fifty cents (\$5,936,028.50), with no matching funds; and

**WHEREAS**, the sum of modification #2, modification #3, and modification #4 to the funding of grant award #G12GA0003A (“grant award”) is an increase of fifty-nine thousand, five hundred forty-seven dollars and fifty cents (\$59,547.50), bringing the grant award to a new total of five million, nine hundred thirty-six thousand, twenty-eight dollars and fifty cents (\$5,936,028.50), with no matching funds; and

**WHEREAS**, modifications #2, #3, and #4 to grant G12GA0003A were approved by Council and the Mayor through ordinance 13-O-0027; and

**WHEREAS**, ONDCP further modified grant award #G12GA0003A with modification #5, which increased the award by fifty thousand dollars (\$50,000), bringing the grant award to a new total of five million, nine hundred eighty-six thousand, twenty-eight dollars and fifty cents (\$5,986,028.50), with no matching funds; and

**WHEREAS**, the Department wishes to accept modification #5 to grant G12GA0003A to continue funding the Atlanta HIDTA task force.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS**, as follows:

**SECTION 1:** That the 2013 (Intergovernmental Grant Fund) Budget, Department of Police, is hereby amended as follows:
