A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH ARCHER WESTERN/ LEWIS CONTRACTING, JV FOR FC-6912, SOUTHEAST ATLANTA GREEN INFRASTRUCTURE INITIATIVE, PHASE 2A - MEDIA LOT 5 MG STORAGE VAULT, ON BEHALF OF THE DEPARTMENT OF WATERSHED MANAGEMENT, IN AN AMOUNT NOT TO EXCEED NINETEEN MILLION, FIVE HUNDRED NINETY-SIX THOUSAND, ONE HUNDRED ELEVEN DOLLARS AND NO CENTS (\$19,596,111.00); ALL CONTRACTED WORK WILL BE CHARGED TO AND PAID FROM FUND DEPARTMENT ORGANIZATION AND ACCOUNT NUMBER ("FDOA") 5052 (WATER AND WASTE WATER REVENUE AND EXTENSION FUND) 171002 (DWM SEWAGE LINEAR MAINTENANCE/REPAIR) 5414002 (FACILITIES OTHER THAN BUILDINGS) 4330000 (FACILITIES OTHER THAN BUILDINGS) AND PROJECT TASK AWARD EXPENDITURE AND ORGANIZATION NUMBER ("PTAEO") 17111415 (CUSTER AVENUE CSO CAPACITY RELIEF) 104 (SOUTHEAST ATLANTA GREEN INFRASTRUCTURE) 505221391 (WATER AND WASTE WATER REVENUE AND EXTENSION FUND) 5414002 (FACILITIES OTHER THAN BUILDINGS) COA; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") advertised for FC-6912, Southeast Atlanta Green Infrastructure Initiative, Phase 2A - Media Lot 5 MG Storage Vault, on behalf of the Department of Watershed Management; and

WHEREAS, the Commissioner of the Department of Watershed Management requires design/build and construction services for the purposes of the construction of a 5 MG underground concrete storage structure and the installation of appurtenances at Hank Aaron Drive to provide additional capacity in the Peoplestown, Mechanicsville and Summerhill communities of Southeast Atlanta; and

WHEREAS, the completion time contemplated for this project is one hundred twenty (120) days for substantial completion from the date of the notice to proceed and forty-five (45) days from the date of substantial completion for final completion; and

WHEREAS, the Commissioner of the Department of Watershed Management and the Chief Procurement Officer have recommended that FC-6912, Southeast Atlanta Green Infrastructure Initiative, Phase 2A - Media Lot 5 MG Storage Vault, be awarded to Archer Western/ Lewis Contracting, JV in an amount not to exceed Nineteen Million, Five Hundred Ninety-Six Thousand, One Hundred Eleven Dollars and No Cents (\$19,596,111.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, or his authorized designee, is authorized to enter into an Agreement with Archer Western/ Lewis Contracting, JV for FC-6912, Southeast Atlanta Green Infrastructure Initiative, Phase 2A - Media Lot 5 MG Storage Vault, in an amount not to exceed Nineteen Million, Five Hundred Ninety-Six Thousand, One Hundred Eleven Dollars and No Cents (\$19,596,111.00).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer, in consultation with the City Attorney, is directed to prepare all appropriate documents for execution by the Mayor;



BE IT FURTHER RESOLVED, that the Agreement will not become binding on the City and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to Archer Western/ Lewis Contracting, JV; and

AND FINALLY BE IT RESOLVED, that all contracted work will be charged to and paid from the listed Fund Department Organization and Account Number 5052 (Water And Waste Water Revenue And Extension Fund) 171002 (DWM Sewage Linear Maintenance/Repair 5414002 (Facilities Other Than Buildings) 4330000 (Facilities Other Than Buildings) and Project Task Award Expenditure and Organization Number 17111415 (Custer Avenue CSO Capacity Relief) 104 (Southeast Atlanta Green Infrastructure) 505221391 (Water and Waste Water Revenue and Extension Fund) 5414002 (Facilities Other Than Buildings) COA.
