




AN ORDINANCE BY COUNCILMEMBER YOLANDA ADREAN TRANSFERRING \$5,000.00 IN FUNDS FROM THE DISTRICT 8 COUNCILMEMBER CARRY-FORWARD IN THE NON-DEPARTMENTAL RESERVES TO ASSIST THE BUCKHEAD HERITAGE SOCIETY IN THE DEVELOPMENT OF A BUCKHEAD INTERPRETIVE MASTER PLAN FOR THE BUCKHEAD COMMUNITY; AND FOR OTHER PURPOSES.

WHEREAS, in 2010, an outgrowth of the Buckhead Greenspace Action Plan was the need for a Buckhead Interpretive Master Plan that would be used to develop the Cultural and Historical Resources Vision outlined in the Greenspace Action Plan; and

WHEREAS, the Livable Buckhead and the Buckhead Heritage Society will guide the development of the interpretive master plan, which when fully implemented will communicate significant historical Buckhead stories by integrating them into current and future parks, trails and other green spaces within the Buckhead Community; and

WHEREAS, the Buckhead Heritage Society is actively fundraising for the development of the interpretive master plan which already has the support of various Buckhead community and business organizations; and

WHEREAS, the Heritage Society is still lacking funds for the project, which will cost a projected total of \$53,110.00 to complete; and

WHEREAS, there are \$5,000.00 in funds available within the District 8 Councilmember carry-forward in the non-departmental reserves to assist with the development of the Buckhead Interpretive Master Plan.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized to remit payment to the Buckhead Heritage Society amount of \$5000.00 to go towards the development of the Buckhead Interpretive Master Plan.

SECTION 2: That all payments shall be charged to and made from the following:
