AS SUBSTITUTED BY FINANCE/EXECUTIVE COMMITTEE

AN ORDINANCE AMENDING THE FISCAL 2014 GERNERAL FUND BUDGET IN THE AMOUNT OF \$15,000.00 BY TRANSFERRING APPROPRIATIONS FROM THE DISTRICT 3 COUNCILMEMBER NON-DEPARTMENTAL CARRY FORWARD EXPENSE ACCOUNT TO THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT (\$5,000.00) TO FUND THE MODIFICATION OF THE LIVABLE CENTERS INITIATIVE PLAN TO INCLUDE THE COMPONENTS OF THE WASHINGTON PARK COMMUNITY'S NEIGHBORHOOD PLAN AND THE DEPARTMENT OF PARKS AND RECREATION (\$10,000.00) TO CONTRIBUTE TO THE DEVELOPMENT OF THE WEST LAKE PARK AND TO AUTHORIZE A CONTRIBUTION IN THE AMOUNT OF \$875.00 TO THE ATLANTA POLICE FOUNDATION; AND FOR OTHER PURPOSES.

WHEREAS, the District 3 Councilmember, in conjunction with the Atlanta Regional Commission and City of Atlanta Quality of Life Bonds funded a 2009 Livable Centers Initiative Plan for the Vine City/Washington Park Community, and

WHEREAS, The Office of Planning and Neighborhood Planning Unit have allocated money to implement the Livable Centers Initiative Plan, and

WHEREAS, The District 3 Councilmember wants to support the Washington Park Community's desire to implement the Livable Centers Initiative and efforts to modify the plan by including components of the neighborhood plan, by seeking authorization to contribute \$5,000 to the Community's effort, and

WHEREAS, The West Lake Park Project provide additional green space to the city, increase of pride in the community, and improve the quality of life for residents, and

WHEREAS, the District 3 Councilmember is seeking authorization to contribute \$10,000 to fund the West Lake Park Project for the residents of West Lake and the City of Atlanta, and

WHEREAS, the District 3 Councilmember is seeking authorization to contribute funds in the support of the Atlanta Police Foundation in the amount of \$875.00.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized to amend the FY14 budget by transferring cash appropriations from the 1001 (General Fund) \$10,000 to 3501 (Park Improvement Fund)


