A RESOLUTION AUTHORIZING RENEWAL NO. 1 WITH A & D PAINTING, INC. FOR FC-5213, ANNUAL CONTRACT FOR PAINTING AND PRESSURE WASHING SERVICES, ON BEHALF OF THE DEPARTMENT OF WATERSHED MANAGEMENT, IN AN AMOUNT NOT TO EXCEED FOUR HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$400,000.00); ALL CONTRACT WORK SHALL BE CHARGED TO AN PAID FROM FUND DEPARTMENT ORGANIZATION AND ACCOUNT NUMBERS IN THE FOLLOWING AMOUNTS: \$350,000 - 5051 (WATER & WASTEWATER REVENUE) 170241 (DWM WATER TREATMENT COMPLEX - CHATTAHOOCHEE) 5222002 (REPAIR & MAINTENANCE-EQUIPMENT) 4430000 (TREATMENT); \$50,000 - 5051 (WATER & WASTEWATER REVENUE) 170204 (DWM TREATMENT PLANT - RM CLAYTON) 5222002 (REPAIR & MAINTENANCE-EQUIPMENT) 4335000 (SEWAGE TREATMENT); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") authorized FC-5213, Annual Contract for Painting and Pressure Washing Services ("Agreement") with A & D Painting, Inc., on behalf of the Department of Watershed Management, pursuant to Resolution No. 11-R-0743; and

WHEREAS, the term of the Agreement is for two (2) years with two (2) one (1) year renewal options to be exercised at the City's sole discretion effective November 4, 2011 through November 3, 2013; and

WHEREAS, A & D Painting, Inc. continues to satisfactorily perform services under the Agreement; and

WHEREAS, the Commissioner of the Department of Watershed Management and the Chief Procurement Officer recommend authorizing the City's option for Renewal No. 1 with A & D Painting, Inc. for FC-5213, Annual Contract for Painting and Pressure Washing Services in an amount not to exceed Four Hundred Thousand Dollars and Zero Cents (\$400,000.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, or authorized designee, is authorized to exercise the City's option for Renewal No. 1 with A & D Painting, Inc. for FC-5213, Annual Contract for Painting and Pressure Washing Services, on behalf of the Department of Watershed Management, in an amount not to exceed Four Hundred Thousand Dollars and Zero Cents (\$400,000.00); and

BE IT FURTHER RESOLVED, that the term of Renewal No. 1 will be November 4, 2013 through November 3, 2014; and

BE IT FURTHER RESOLVED, that the Chief Procurement Officer, in consultation with the City Attorney, is directed to prepare all appropriate documents for execution by the Mayor, or his authorized designee; and



BE IT FURTHER RESOLVED, that Renewal No. 1 will not become binding on the City and the City will incur no obligation or liability under it until it has been duly executed by the City and delivered to A & D Painting, Inc.; and

BE IT FINALLY RESOLVED that all contract work shall be charged to an paid from Fund Department Organization and Account Numbers in the following amounts: \$350,000 - 5051 (Water & Wastewater Revenue) 170241 (DWM Water Treatment Complex - Chattahoochee) 5222002 (Repair & Maintenance-Equipment) 4430000 (Treatment); \$50,000 - 5051 (Water & Wastewater Revenue) 170204 (DWM Treatment Plant – RM Clayton) 5222002 (Repair & Maintenance-Equipment) 4335000 (Sewage Treatment).
