## **Robin Loudermilk, Jr.**

Robert C. (Robin) Loudermilk, Jr., is currently the President and Chief Executive Officer of The Loudermilk Companies, LLC, an asset based real estate management company based in Atlanta, Georgia, a post he has held since December of 2011, and a Partner in Loudermilk Bell. Loudermilk Bell, LLC ("LB") was formed in 2007 as a real estate joint venture between Robin Loudermilk, President of the Loudermilk Companies, and Dwight Bell, President of Cannon Equities.

Prior to The Loudermilk Companies, he served as President and Chief Executive Officer of Aarons Inc. (NYSE AAN) from 2008 through November 2011 and President and Chief Operating Officer from 1997 through 2008. Mr. Loudermilk joined Aaron's in 1985 as an assistant store manager and held various positions: a Director since 1992, Regional Vice President, Vice President Manufacturing, Vice President Rent-to-Rent Division, Vice president Real Estate & Construction, Store Manager and Vice president Office Furniture Division. Additionally, he was Vice President of Ball Stalker, a wholly owned subsidiary of Aarons. Prior to his career with Aarons, Inc., he worked for Caldwell Banker Commercial Real Estate Services, and subsequently Stratton Construction Inc.

Mr. Loudermilk currently serves as investor and business advisor to State Traditions, LLC and is a Principal at Main Street Parking. He founded The Public Safety organization The Buckhead Alliance and currently serves on the boards of Genuine Parts Company (NYSE GPC), The Atlanta Police Foundation and the Buckhead Community Improvement District. Mr. Loudermilk is a member of the Buckhead Coalition, the Downtown Atlanta Rotary Club, and is a former member of the Young Presidents Organization.

A native of Atlanta, GA, Robin graduated from the Lovett School in 1978, where he now serves as a trustee. He attended the University of Alabama and graduated in 1982 with an undergraduate degree in General Business Administration.
