**AN ORDINANCE BY
COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE**

AN ORDINANCE AMENDING THE INTERGOVERNMENTAL GRANT FUND AND THE DCA-CDBG-R GRANT FUND BUDGETS BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS PROGRAM INCOME AS IT IS GENERATED BY THE CITY OF ATLANTA'S DCA-COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY, THE EMPOWERMENT ZONE/ENTERPRISE COMMUNITY INITIATIVE AND URBAN REDEVELOPMENT LAND GRANTS; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to the Supplemental Appropriations Act, 2009 (Public Law 110-329, approved September 20, 2009) Congress made available certain Community Development Block Grant Supplemental Disaster Recovery ("DCA-CDBG-R") funds for disaster relief of unmet needs; and

WHEREAS, the Georgia Department of Community Affairs conditioned the award on the governing authority, by resolution establishing policies and procedures to be used by the City of Atlanta ("City") for the administration of program income generated from the DCBG-R; and

WHEREAS, the City also received a U.S. Department of Health and Human Services Grant in connection with the Empowerment Zone/Enterprise Community Initiative (the "EZ") authorized by Ordinance 96-O-0309, adopted by City Council March 4, 1996 and approved by the Mayor March 11, 1996; and

WHEREAS, in addition to the DCA-CDBG-R and the EZ, the City has also received Urban Redevelopment Land grants from U.S. Department of Housing and Urban Development ("URL"); and

WHEREAS, DCA-CDBG-R, EZ, and the URL programs each generate program income and it is necessary to anticipate and appropriate the program income generated by DCA-CDBG-R, EZ, and the URL programs as it is generated, so that the City may make the funds readily available for further housing development activities; and

WHEREAS, the City's Department of Planning and Community Development ("DPCD"), Office of Housing is seeking authorization to anticipate and appropriate the CDBG-R, EZ, and the URL program income as it is generated so that the City's Department of Finance may record this program income for future use in other housing projects.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the Chief Financial Officer is authorized to allocate up to twenty percent (20%) of program income generated from the City's DCA-CDBG-R, EZ, and the URL programs for administrative costs.



Section 2: That the Chief Financial Officer is authorized to anticipate and record program income in Oracle as it is generated as follows:

a. Program income generated under the DCA-CDBG-R shall be recorded:


