AN ORDINANCE
BY COUNCIL MEMBER(S)

AN ORDINANCE AUTHORIZING THE CHIEF FINANCIAL OFFICER TO AMEND THE FISCAL YEAR 2014 BUDGET BY TRANSFERRING APPROPRIATIONS FROM THE DEPARTMENT LAW IN A TOTAL AMOUNT OF EIGHT HUNDRED SIXTHY THOUSAND ONE HUNDRED FIFTY-ONE DOLLARS AND SEVENTEEN CENTS (\$860,151.17) IN ORDER TO FUND THE CONTRACTED WORK FOR THE RENOVATIONS, FURNITURE PURCHASES AND IT EQUIPMENT FOR THE BUILD-OUT OF THE CITY OF ATLANTA'S DEPARTMENT OF LAW MOVE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta's ("City") Department of Law is moving from its current office space at 15 Mitchell Street to 55 Trinity Avenue (the "Project"); and

WHEREAS, the space located at 55 Trinity Avenue is in need of complete office renovations before the Law Department can be relocated; and


WHEREAS, the Chief Financial Officer also recommends amending the Fiscal Year 2014 Budget by transferring appropriations from the Department of Law in the amount of Eight Hundred Sixty Thousand One Hundred and Fifty-One Dollars and Seventeen Cents (\$860,151.17) in order to fund the Project.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS AS FOLLOWS:

SECTION 1: That the Chief Financial Officer is authorized to amend the Fiscal Year 2014 budget by transferring appropriations from the Department of Law in a total amount of Eight Hundred Sixty Thousand One Hundred and Fifty-One Dollars and Seventeen Cents (\$860,151.17) as follows:
