**AN ORDINANCE TO AMEND ORDINANCE NO. 11-O-1553 ADOPTED BY THE ATLANTA CITY COUNCIL ON NOVEMBER 21, 2011 AND APPROVED ON NOVEMBER 30, 2011 PURSUANT TO CITY CHARTER SECTION 2-403, SO AS TO PROVIDE THAT ALL UTILITY RELOCATION AND CONSTRUCTION RELATED ACTIVITIES ASSOCIATED WITH THE ATLANTA STREETCAR PROJECT ARE EXEMPTED FROM THE ATLANTA NOISE ORDINANCE, CODE SECTIONS 74-129 THROUGH 74-160, FOR AN ADDITIONAL PERIOD THROUGH AND INCLUDING APRIL 2014, FOR THE PURPOSES RELATED TO COMPLETION OF THE PROJECT BY THE FEDERALLY IMPOSED DEADLINES; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta was awarded a TIGER II grant to fund the construction of the Atlanta Streetcar Project ("Project"); and

**WHEREAS**, the first phase of the Project will extend for approximately 2.7 miles in the heart of Atlanta's downtown, business, tourism and convention corridor located along Peachtree Street, Luckie Street, Edgewood Avenue and Auburn Avenue, connecting Centennial Olympic Park with the Sweet Auburn and Edgewood districts; and

**WHEREAS**, completion of the Project will involve utility relocations and construction that may result in loud noises; and

**WHEREAS**, meeting the federally imposed deadlines, including final completion by April 2014, may require construction of the Project to operate 24 hours a day and 7 days a week; and

**WHEREAS**, the noise created by the construction of the Project between 7 p.m. and 7 a.m. on weekdays and between 7 p.m. and 9 a.m. on weekends and legal holidays may violate the provisions of the Atlanta Noise Ordinance, City of Atlanta Code of Ordinance sections 74-129 through 74-160; and

**WHEREAS**, the Atlanta Noise Ordinance has a provision allowing for a temporary variance from the Noise Ordinance, but the temporary variance lasts for forty-five days and must be renewed for each forty-five day period thereafter; and

**WHEREAS**, Ordinance No. 11-0-1553, approved by the Atlanta City Council as per the City Charter on November 30, 2011, waives the Noise Ordinance for construction of the Project; however, said waiver expired as of May 2013.

**WHEREAS**, because the construction of the Project will last for approximately an additional five months through and including April 2014, the Department of Public Works has recommended that the Project seek the adoption of an ordinance waiving the provisions of the Atlanta Noise Ordinance, rather than seeking numerous temporary variances; and



**WHEREAS**, the City is willing to waive the Noise Ordinance provisions because the waiver is related to the construction of the Project.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS AS FOLLOWS:**

**Section 1:** That City of Atlanta Ordinance No. 11-0-1553, approved by the Atlanta City Council as per the City Charter on November 30, 2011, is hereby extended for an additional period through and including April 2014 as follows:


- A. That Atlanta City Code Sections 74-129 through 74-160, known collectively as the Atlanta Noise Ordinance, are hereby waived for all utility relocations and construction related activities with regard to the Atlanta Streetcar Project and performed along the Atlanta Streetcar route, through and including April 2014.
- B. **Clarification of effect:** This waiver shall only apply to any work done for purposes related to the utility relocations and construction related activities with regard to the Atlanta Streetcar Project and performed along the Atlanta Streetcar route after notification as provided herein has been accomplished.
- C. **Waiver document required:** Before the use of the waiver provided in this ordinance can be exercised, it shall be necessary to obtain approval from the Commissioner of the Department of Public Works showing that to the extent reasonably possible, the notification of the schedule and notification of affected constituents has been undertaken.
- D. **Notification of schedule:** The following steps shall be undertaken to notify affected constituents along the Atlanta Streetcar route of the receipt of the construction schedule for the Atlanta Streetcar as soon as it reasonably possible to do so utilizing as many of the following methods as it reasonably possible to undertake:
  - 1. Notice to all members of the City Council
  - 2. Meetings with Neighborhood Planning Units and property owners
  - 3. Town hall meetings with residents and businesses
  - 4. Door to Door visits leaving information packets
  - 5. Announcement on Channel 26
  - 6. Public Service announcement
  - 7. Street signs
  - 8. Website links
  - 9. Meeting with churches located on the Project Route
- E. **Notification of waiver application:** The following steps shall be undertaken to notify affected constituents along the Atlanta Streetcar route of the waiver application as soon as it is reasonably possible to do so utilizing as many of the following methods as it reasonable to do so, but in no case less than five business (5) days prior to the date that the waiver is expected to be issued.



1. Notice to all members of the City Council
2. Meetings with Neighborhood Planning Units and property owners
3. Town hall meetings with residents and businesses
4. Door to Door visits leaving information packets
5. Announcement on Channel 26
6. Public Service announcements
7. Street signs
8. Website links
9. Meeting with churches located on the Project Route

F. **Coordination of Schedule:** Based on the information received, the Commissioner of the Department of Public Works shall prepare a schedule for the work for which an exemption is requested in order to coordinate the work in a manner that will cause the least disruption to the affected areas through the issuance of the waiver; provided however, that with any work which is more likely to disturb the public, that every reasonable effort shall be made to perform such construction in residential areas during daytime hours, in commercial areas during nighttime hours, and in the vicinity of churches and other places of worship at times which do not conflict with the holding of services or other activities.

**Section 2:** That all other ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of said conflict in this instance only.
