MAYOR'S ACTION

**AN AMENDED ORDINANCE
BY CITY UTILITIES COMMITTEE**

AN ORDINANCE TO AMEND CHAPTER 154 (UTILITIES), ARTICLE III (WATER), DIVISION 1 (GENERALLY) OF THE CITY OF ATLANTA, CODE OF ORDINANCES, FOR THE DEPARTMENT OF WATERSHED MANAGEMENT BUREAU OF DRINKING WATER TO ADJUST METER AND HYDRANT SERVICE AND INSTALLATION FEES; AND FOR OTHER PURPOSES.

WHEREAS, the Bureau of Drinking Water (“BDW”) performs engineering review and approval of plans for drinking water service, fire service to new developments for which BDW charges a fee to recuperate the costs associated with such work; and

WHEREAS, BDW performs plan review and approval for the installation of new water meters, and it has been more than five years since the installation fees have been reviewed and updated to reflect actual costs to BDW; and

WHEREAS, BDW inspects and performs work associated with the relocation and abandonment of water meters, upon the request and application of its customers, for which BDW charges a fee to recuperate the costs associated with such work; and

WHEREAS, BDW performs work associated with re-installing and reestablishing water meters at locations previously abandoned, upon the request and application of its customers, for which no fee was previously assessed but should be assessed to recuperate the costs associated with such work; and

WHEREAS, BDW performs certain fire flow testing and inspection upon the request and application of its customers in connection with new fire service locations, for which BDW charges a fee to recuperate the costs associated with such work; and

WHEREAS, BDW desires to update and include such fees as are appropriate to reflect the actual costs associated with the work and services performed at the request of its customers; and

WHEREAS, the Commissioner of the Department of Watershed Management, pursuant to Section 154-67(b) of the City Code, has determined that an adjustment to such fees are appropriate to capture the actual costs to the Department and make the water and sewer fund whole for services provided to its customers.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS
as follows:

SECTION 1.

That Chapter 154 (Utilities), Article III (Water), Division 1 (Generally) is hereby amended in the appropriate provisions corresponding with the fees for the itemized services as set forth below:

SECTION 2.

That Chapter 154, Article III, Division 1, be amended to add a new section for the establishment of a fee to recover the costs for services provided associated with the reestablishment of water services, as set forth below:

SECTION 3.

That Chapter 154, Article III, Division 1, Sections 154-68 be amended by adding the following sections to set the fee for the installation of water meters of two (2) inch in diameter or less:

(f) *Fee for Meter Installation of Water Meters of 2 inch in diameter or less*

(1) The fee and deposit schedule for water meter plan review and installation for water meters of 2 inch in diameter or less shall be as follows:

- (2) Design plans are required for water meter installations of 3 inches or more in diameter. These meters must be paid for and installed by the Applicant. Upon application, the city will perform a plan review for the installation of the water meter of 3 inches or more in diameter. The fee for the plan review and inspection is \$5,400.00. A deposit of \$2,000.00 is required at the time the application is submitted. A pre construction conference will be held with the Applicant. Once the plans have been approved, At the time of the pre construction conference, all remaining fees must be paid and all required documents must be submitted to the city.

SECTION 4.

That Chapter 154 (Utilities), Article III (Water), Division 2 (Fire Hydrants), Section 154-91 be amended by deleting the existing section and replacing it with the following:

Sec. 154-91. - Installation of detector meter fire line meter and tap for fire service systems having fire hydrants.

(a) *Inspection of Fire Service Installation.* Fire service installation of detector meters or factory mutual fire meters (“fire service”) must be performed by the owner and will be subject to inspection by the city. Upon application, the city will perform a plan review for the installation of the fire service. The fee for the plan review and inspection is \$5,400.00. A deposit of \$2,000.00 is required at the time the application is submitted. This deposit is partially refundable except as set forth in Section 154-67(b)(1)(d), and is applied to cover the City's costs.

(b) Once the plans are approved by the Department, installation of the fire service by the Applicant may not begin until full payment for the inspection of the meter has been made by the Applicant.

(c) *Standby charge.* The regular monthly fire service standby charge shall be continued for fire service installations having a detector meter. The Commissioner shall bill factory mutual fire line meters at metered rates.

(d) The fee for performing fire service hydraulic tests shall be as follows:

SECTION 5.

That all ordinances in conflict with this ordinance are hereby waived to the extent of the conflict.
