AUTHORIZING THE MAYOR OR HIS DESIGNEE TO CREATE A PARKING PASS PROGRAM FOR ALL DULY APPOINTED MEMBERS OF CITY BOARDS AND COMMISSIONS; AND FOR OTHER PURPOSES.

WHEREAS, the Mayor and City Council regularly nominate, appoint and confirm citizens to various City Boards and Commissions; and

WHEREAS, Board and Commission members are tasked with carrying out vital City business; and,

WHEREAS, In the course of their official duties, Board and Commission members must attend meetings and hearings at Atlanta City Hall; and

WHEREAS, Parking in and around City Hall can be limited, costly and/or inconvenient.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES as follows:

Section 1: That the Mayor or his designee is authorized to create a parking pass program for duly appointed members of City Boards and Commissions.

Section 2: That the City issued passes will allow parking for Board and Commission members on both sides of Mitchell Street, SW, Washington Street, SW, Trinity Avenue, SW or Central Avenue, SW.

Section 3: That the parking pass supplied by the City to each Board and Commission member will be effective only for the period of his/her Board or Commission term as adopted by Council and approved by the Mayor.

Section 4: That the parking pass will allow the Board or Commission member to park only on the day and for the length of time that appointees Board or Commission officially meets.

Section 5: That Each Board or Commission member must clearly display the City issued parking pass on the driver's side dashboard of his/her car.

Section 6: That all ordinances and parts of ordinances in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of the conflict.
