MAYOR'S ACTION

AN ORDINANCE

BY COUNCILMEMBER KWANZA HALL

AN ORDINANCE AUTHORIZING THE
MAYOR OR HIS DESIGNEE TO IMPOSE A
MORATORIUM ON STREET NAME
CHANGES FOR SIX (6) MONTHS; AND
FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta has renamed several streets in the recent past and some have not been well received; and

WHEREAS, some neighborhood groups and individuals have objected to certain streets being changed; and

WHEREAS, the City needs to review its policy for renaming a street and explore other alternatives for honoring an individual; and

WHEREAS, some cities allow the street name to remain and place different color signage above the street sign (toppers) honoring an individual; and

WHEREAS, this or some other alternative may be more suitable to the neighborhood groups and individuals that have had objections in the past.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA as follows:

SECTION 1: That Mayor or his designee is authorized to impose a moratorium on the renaming of city streets for six (6) months while the Utilities Committee or a Task Force review the current process and prepare recommendations.

SECTION 2: This moratorium will not affect any proposed renaming legislation that has been introduced.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
