**WHEREAS**, The Brookwood Alliance Plan was developed at the request of the Brookwood Alliance by the Spring 2010 Georgia Tech Urban Design Studio; and

**WHEREAS**, the residents and property owners of in the Brookwood Alliance, consisting of Collier Hills, Collier Hills North, Ardmore, Brookwood and Brookwood Hills, worked with the Spring 2010 Georgia Tech Urban Design Studio led by professors David Green and Richard Dagenhart to develop vision for future development as well as design strategies to implement the vision; and

**WHEREAS**, this planning document entitled the Brookwood Alliance Plan has been developed based on the direct input of the residents, property owners and other stakeholders in the study area; and

**WHEREAS**, this document meets the minimum planning requirements and has been reviewed by the Office of Planning; and

**WHEREAS**, the City wishes to adopt the Brookwood Alliance Plan as a guide for future development and incorporate the plan by reference into the 2011 Comprehensive Development Plan; and

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS AS FOLLOWS:**

**SECTION 1:** That the document entitled Brookwood Alliance Plan, attached hereto as Exhibit "A" and incorporated herein by reference, is hereby adopted.

**SECTION 2:** That the 2011 Comprehensive Development Plan is hereby amended to incorporate by reference the planning document entitled Brookwood Alliance Plan.

**SECTION 2:** That all ordinance and parts of ordinances that are with this ordinance are hereby rescinded to the extent of the conflict.
