A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ENTER INTO AN AGREEMENT BETWEEN THE CITY OF ATLANTA AND THE URBAN VILLA NEIGHBORHOOD ASSOCIATION ALLOWING THE INSTALLATION OF A NEIGHBORHOOD SIGN WITHIN A CERTAIN RIGHT-OF-WAY; AND FOR OTHER THE PURPOSES.

WHEREAS, The Urban Villa Neighborhood Association desires to install and maintain a neighborhood an identification sign; and,

WHEREAS, The Urban Villa Neighborhood Association desires to install a sign at the; northwest corner of Joseph E. Boone Boulevard, NW and Simpson Terrace, NW and,

WHEREAS, The installation of the sign will serve to preserve the history and unique character of the Urban Villa neighborhood.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Mayor or his designee is authorized to enter into an agreement with the Urban Villa Neighborhood Association to allow for the installation of a neighborhood identification sign which is to be installed at the following location:

Joseph E. Boone Boulevard, NW and Simpson Terrace, NW

SECTION 2: That the plans and specifications for said signs shall be submitted for the review and approval of the Commissioner of Public Works prior to any sign being installed as well as acquiring al necessary permits needed for the installation.

SECTION 3: That Urban Villa Neighborhood Association shall indemnify the City for any damages to persons or properties resulting from the installation and maintenance of said sign.

SECTION 4: The proposed sign shall be reviewed by the Urban Design Commission as it relates to design and location.

SECTION 5: The City Attorney is authorized to prepare and approve an agreement as to form and it will not become binding upon the City until executed by the Mayor, attested to by the Municipal Clerk and delivered to the Urban Villa Neighborhood Association.

SECTION 6: That all resolutions and parts of resolutions in conflict herewith be and the same are hereby waived in this instance only.
