AN ORDINANCE

BY COUNCILMEMBER CLETA WINSLOW

AN ORDINANCE TO TRANSFER \$80,232.00 (EIGHTY THOUSAND TWO HUNDRED THIRTY TWO DOLLARS) FROM THE FIRE IMPACT FEE FUND ACCOUNT TO A SPECIFIC PROJECT CENTER DESIGNATED ACCOUNT IN THE DEPARTMENT OF FIRE AND RESCUE FOR THE PURPOSE OF PROVIDING NEEDED FUNDING FOR THE ASSESSMENT, REASSEMENT AND RENOVATION OF FIRE STATION # 7; TO WAIVE CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, Atlanta Fire and Rescue Station #7 was built in 1910 and has been in continuous operation and has been a great service to the community; and

WHEREAS, the community of West End highly values the historic firehouse and has expressed its wishes that the building be renovated and continue as a working fire station; and

WHEREAS, Fire Station #7, over 100 years old, is in need of an assessment and a reassessment to determine the current state of the structure, mechanical, electrical and plumbing systems, as well as an assessment of environmental conditions; and

WHEREAS, there are funds available in the Fire Impact Fee Fund Account to cover the cost of this needed assessment, reassessment and renovation of Fire Station #7.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEOTGIA, as follows:

Section 1: That the General Government Capital Outlay Fund, Fire and Rescue Department be and is hereby amended as follows:
