**AN ORDINANCE BY  
FINANCE/EXECUTIVE COMMITTEE**

**AN ORDINANCE TO AMEND ORDINANCE 11-O-1290 TO EMPOWER THE COMMISSIONER OF PLANNING AND COMMUNITY DEVELOPMENT TO AUTHORIZE OVERTIME AND INCENTIVE PAY TO DEPARTMENTAL PERSONNEL FOR HOURS ASSIGNED TO BE WORKED IN EXCESS OF THE REGULAR WORK WEEK TO PROVIDE ADDITIONAL PLAN REVIEW SERVICES AS SET FORTH IN SECTION 104 (1) OF APPENDIX "A" TO VOLUME III OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA WHICH CONTAINS THE BUILDING CODE AMENDMENTS.**

**WHEREAS**, there is an increased demand from certain segments of the users of the services of the Office Buildings for additional services above that which is provided at a level of service at the cost recovery rates based on fee calculated on the value of construction; and

**WHEREAS**, additional services such as inspection or plan review appointments which occur outside of regular business hours, expedited plan review requiring overtime hours by plan reviewers or other specialized services are an enhancement to the service provided by the Office of Buildings for which additional fees must be charged in order to provide such services; and

**WHEREAS**, the legislation adopting additional fees for plan review services, 11-O-1290, was adopted on October 17, 2011; and

**WHEREAS**, the purpose of the fees for additional plan review services is for the compensation of personnel and administrative costs within the Office of Buildings to provide such expedited services.

**NOW THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS AS FOLLOWS:**

**Section 1:** That Commissioner of Planning and Community Development is hereby authorized to grant paid overtime for classified personnel and incentive pay based on the hourly rate for unclassified employees, for any hours worked in excess of forty (40) hours during the workweek. Such overtime and incentive pay shall be authorized only when the Director of the Office of Buildings receives a written request for additional plan review services, site development and/or erosion control and upon the payment of specified additional fees for such review services pursuant to the Building Code Amendments fee schedule contained in Section 104.2 (1) of Appendix A of Part III of the Code of Ordinances of the City of Atlanta ("the Land Development Code") entitled "Building Code Amendments".

**Section 2:** The overtime and incentive pay authorized herein shall be limited only to the allowable additional plan review services, sit development and/or erosion control and in the manner as set forth in Section 104.2 (l) of Appendix A of Part III of the Code of Ordinances of the City of Atlanta (“the Land Development Code”) entitled “Building Code Amendments”.

**Section 3:** Such salary expenses shall be charged to and paid from Fund Accounts and Centers as appropriate within the Department of Planning and Community Development as authorized and created for the purposes to receive any new fees set forth in Section 104.2 (l) of Appendix A of Part III of the Code of Ordinances of the City of Atlanta (“the Land Development Code”) entitled “Building Code Amendments”.

**Section 4:** That this ordinance shall become effective upon the Mayor’s signature or as specified by City Charter Sec. 2-403.
