COUNCIL DISTRICT 1

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:

SECTION 1. An ordinance to amend the Land Use element of the 2011 Atlanta Comprehensive Development Plan (CDP) so as to redesignate properties that are located at 1144 and 1160 Mailing, 410, 430, 505 Englewood avenue, 14 0041 LL004, 14 0041 LL005, 15 0041 LL008, 14 0041 LL011, 14 0041 LL012, from the Medium density Residential and the Medium Density Mixed Use to the High Density mixed use Land Use designation and for other purposes .

All that tract or parcels of land lying and being in Land Lots 41 and 42 of the 14th of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.
