AN ORDINANCE

BY COUNCILMEMBER AARON WATSON

AS SUBSTITUTED BY FINANCE/EXECUTIVE COMMITTEE

AN ORDINANCE TO AUTHORIZE PAYMENTS TO ATLANTA COMMUNITY-DRIVEN ORGANIZATIONS IN THE AMOUNT OF \$65,000.00 AS OUTLINED IN EXHIBIT A FROM THE POST 2 AT LARGE COUNCILMEMBER CARRYFORWARD IN THE NON-DEPARTMENTAL RESERVES ACCOUNT, AND TO TRANSFER \$10,000 FROM THE CARRY FORWARD TO THE POST 2 AT LARGE OPERATING ACCOUNT; AND FOR OTHER PURPOSES.

WHEREAS, the Post 2 At Large Council Member has supported certain community based activities in the Atlanta community, and

WHEREAS, at this point in the year, the Post 2 At Large Council member would like to allocate a monetary contribution to the community organizations listed in Exhibit A, including;

WHEREAS, the Virginia Highland Civic Association is in the process of producing a Master Plan for the historic neighborhood and needs funding to complete the project, and;

WHEREAS, Senior Connections provides home delivered meals, in-home care and home repair for Atlanta's senior citizens, and

WHEREAS, in addition to the community organizations, the Council Member would like to support downtown Atlanta's first cycle track by transferring funds from the Post 2 carry forward account to the City of Atlanta's transportation department for the cycling project.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized to amend the FY 2014 General fund budget as follows:

Transfer from Appropriations

SECTION 2: That the following amounts are hereby authorized to be contributed to the following projects:

These funds should be used solely for funding the downtown high priority bicycle project.
