

AN ORDINANCE TO AMEND CHAPTER 114, PERSONNEL, ARTICLE IV; CLASSIFICATION PLAN OF THE CODE OF ORDINANCES, CITY OF ATLANTA, GEORGIA, SO AS TO PROVIDE FOR A CERTAIN POSITION CREATION, IN THE DEPARTMENT OF CITY COUNCIL, OFFICE MUNICIPAL CLERK; AND FOR OTHER PURPOSES.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS that the Code of Ordinances of the City of Atlanta, Georgia, be and the same is hereby amended as follows:

SECTION 1 EFFECTIVE DATE OF ACTIONS: That the effective date of actions contained within this ordinance shall be upon adoption by City Council and approval by the Mayor or by operation of law, unless otherwise indicated.
