

**AN ORDINANCE BY  
COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE**

**AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO ACCEPT A GRANT IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND (\$250,000.00) FROM THE MARYLAND WORKFORCE CORPORATION; AMENDING THE 2013 (JOB TRAINING GRANT FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND (\$250,000.00) IN THE ACCELERATING CONNECTIONS TO EMPLOYMENT (ACE) GRANT FUND FROM THE MARYLAND WORKFORCE CORPORATION FOR THE WORKFORCE INNOVATIONS FUND GRANT, TO EXPAND AND IMPROVE EDUCATION, TRAINING, AND EMPLOYMENT OPPORTUNITIES FOR LOW-SKILLED INDIVIDUALS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (“City”) administers special programs under contract to the Atlanta Workforce Development Agency (“AWDA”); and

**WHEREAS**, Accelerating Connections to Employment (“ACE”) is a U.S. Department of Labor funded Workforce Innovations Fund grant; and

**WHEREAS**, ACE is a four state, nine local Workforce Investment Area initiative to expand and improve education, training, and employment opportunities for low-skilled individuals; and

**WHEREAS**, Baltimore County’s Department of Economic Development’s Division of Workforce Development is the grant recipient; and

**WHEREAS**, The Maryland Workforce Corporation (“MWC”) is the project’s administrator and intermediary for all components of the ACE project outside of Baltimore County; and

**WHEREAS**, AWDA has been awarded a portion of the grant in the amount of two hundred fifty thousand dollars (\$250,000.00) to implement and operate the ACE project for its Workforce Investment Area per the Vendor Agreement with MWC; and

**WHEREAS**, AWDA recommends the City to accept the ACE Grant to support its initiative to expand and improve education, training, and employment opportunities for low-skilled individuals; and

**WHEREAS**, AWDA recommends amending the 2013 (Job Training Grant Fund) budget, and increasing the receipts by adding to anticipations and appropriations in the amount of two hundred fifty thousand dollars (\$250,000.00) in the ACE Grant fund.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1:** The Mayor or his designee, on behalf of the City of Atlanta, is authorized to accept a grant in the amount of two hundred fifty thousand dollars (\$250,000.00) from the Maryland Workforce Corporation (“MWC”) for the purpose of expanding and improving education, training, and employment opportunities for low –skilled individuals; and

**Section 2:** That the 2013 (Job Training Grant Fund) budget is hereby amended as follows:






