WHEREAS, the City of Atlanta relies on and encourages the efforts of organizations in communities to aid in providing services and events which contribute to the health, safety and cultural well being of its citizens; and

WHEREAS, to assist these organizations efforts in the community, it is necessary from time to time to provide financial support; and

WHEREAS, it is the desire of the 5th District Councilmember to provide such support in the furtherance of the goals and objectives of these organizations in the District; and
