**ORDINANCE
BY FINANCE/EXECUTIVE COMMITTEE**

AN ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE TO SET THE BASE APPROPRIATION BUDGETED FOR COUNCILMEMBER'S ASSISTANTS AND TO CLARIFY THE SOURCE OF PAYMENT OF FRINGE BENEFITS; AND FOR OTHER PURPOSES. (HELD 5/14/13 FOR THE ADOPTION OF THE BUDGET)

Whereas, the Atlanta City Code of Ordinances provides for each Council member to employ City Council Assistants with the provision that no more than three employees of any category is eligible to receive benefits, and

Whereas, Ordinance 01-O-1088 adopted and approved in July of 2001 amended the Code of Ordinances provided for an annual appropriation for Council Assistants of Seventy Five Thousand Dollars (\$75,000.00), and

Whereas, currently in the City's Fiscal 2013 budget an amount of \$172,625.00 is appropriated for Council member's Assistants, and

Whereas,, it is necessary to clarify the meaning of this Code Section, and eliminate conflicting language regarding the compensation of City Council Assistants.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS:

SECTION 1: That Section 2-152(e) of the Code of Ordinances, which reads:

Annual appropriations for salaries. The amount of \$75,000.00 shall be appropriated annually for the salaries of the assistants authorized in this section, and the cost of insurance or other benefits provided to such employees shall not be charged to such amount. The amount of annual appropriation shall be increased by the appropriate pro rata amount necessary to equal the average amount of any salary increases given to city employees in any given year.

Be amended to read:

Annual appropriations for salaries and benefits. The total amount of \$175,000.00 shall be appropriated annually for the salaries and benefits of the assistants authorized in this section. The amount of annual appropriation shall be increased by the appropriate pro rata amount necessary to equal the average amount of any salary and associated benefit increases given to city employees in any given year.

SECTION 2: That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
