WHEREAS, the Senior Summer Camp at Butler Park provides activities to 75 to 100 senior citizens daily, participating in arts and crafts, computer classes and fitness activities; and

WHEREAS, part of the City’s mission is to support the Community by providing cultural and entertainment options for all citizens, both youth and seniors; and

WHEREAS, the District 5 Councilmember wishes to contribute funds from that District’s Councilmember’s Carry-Forward in the Non-Departmental Reserves to the Senior Summer Camp at Butler Park; and.

WHEREAS, the donation will provide one hot meal, for each week for senior citizens participating.

NOW, THEREFORE , THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:

SECTION 1: That the Chief Financial Officer is authorized to remit payment toward the City Office of Recreation, Department of Parks, Recreation and Cultural Affairs in the amount of \$500.00., and \$106,676.00 to the Department of Public Works.

SECTION 2: That all payments shall be charged to and paid from the following:
