THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:


SECTION 1. An ordinance to amend the Land Use element of the 2011 Atlanta Comprehensive Development Plan (CDP) so as to redesignate property that is located at 3475 Piedmont Road from The Office Institution Land Use designation to the Mixed Use Land Use designation and for other purposes (Z-13-06).

All that tract or parcels of land lying and being in Land Lot 62 of the 17th of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.
