

WHEREAS, Blue Star Museums is a collaboration among the National Endowment of the Arts, Blue Star Families, the Department of Defense, and more than 1,800 museums across America which offers free admission to families with an active duty member of their family serving during this time of combat; and

WHEREAS, this program offers families a chance to visit museums this summer when many will have limited resources and limited time to be together; and

WHEREAS, the Blue Star Museum program runs from Memorial Day to Labor Day; and

WHEREAS, pursuant to Ordinance 13-O-0639 adopted by the Atlanta City Council on May 6, 2013 and approved per City Charter Section 2-403 on May 15, 2013 active military and up to five family members are permitted admission into the Atlanta Cyclorama without charge from Memorial Day Weekend, May 25, 2013 until Labor Day Weekend, September 2, 2013; and

WHEREAS, due to the overwhelming public demand for the Blue Star Museum program at Atlanta Cyclorama, the City desires to extend free admission to military veterans, as well as active military.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the Mayor, on behalf of the City, is authorized to waive the provisions contained in Chapter 110, Article I, Section 110-3(c) entitled "Atlanta Cyclorama Admissions" of the City of Atlanta Code of Ordinances and specifically waiving the admission fee so as to allow for military veterans and up to five family members admission without charge from Memorial Day Weekend, May 25, 2013 until Labor Day Weekend, September 2, 2013, in conjunction with the Blue Star Museum Program.

SECTION 2: That DPRCA will comply with all other provisions contained in Section 110-3(c) of the City Code of Ordinances.

SECTION 3: That all ordinances and resolutions in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of said conflict.
