WHEREAS, the streetscape project on West Peachtree Street, N.W. and Marietta Street, N.W. has been recently completed; and

WHEREAS, prior to the completion of the streetscape project, parking spaces were limited to loading, unloading and no parking tow zones; and

WHEREAS, the Office of Transportation received a request to designate eleven (11) parking spaces as time limited parking spaces with two (2) spaces to be located on West Peachtree Street, N.W. between Simpson Street, N.W. and West Peachtree Place, N.W. and nine (9) spaces to be located on Marietta Street, N.W. between Peachtree Street, N.W. and Broad Street, S.W., as shown in Exhibit "A", attached hereto.
