

**ORDINANCE

**AN ORDINANCE BY COUNCILMEMBER MICHAEL J. BOND TO AUTHORIZE THE TRANSFER OF FUNDS IN THE AMOUNT OF \$24,000.00 FROM THE POST 1 AT LARGE COUNCILMEMBER CARRY FORWARD IN THE NON-DEPARTMENT RESERVES TO THE SALARIES, PERMANENT PART-TIME ACCOUNT; AND FOR OTHER PURPOSES.**
