**AN ORDINANCE

**AN ORDINANCE BY COUNCILMEMBER C. T. MARTIN AUTHORIZING THE MAYOR OR HIS DESIGNEE TO PROHIBIT PARKING ON BOTH SIDES OF LYNN CIRCLE, SW FROM LYNN DRIVE, SW TO BENJAMIN E. MAYS DRIVE, SW; FROM 9:00 A.M. TO 1:00 A.M. MONDAY THROUGH FRIDAY- WITH NO PARKING RESTRICTIONS ON SATURDAY AND SUNDAY; AND FOR OTHER PURPOSES.**

WHEREAS, residents on Lynn Circle, SW, have petitioned the city to prohibit parking on both sides of Lynn Circle, SW from Lynn Drive, SW to Benjamin E. Mays Drive from 9:00 a.m. to 1:00 a.m. Monday through Friday; and

WHEREAS, the residents have expressed their concern to their elected representative on the lack of available parking for residents and their guest on this street due in large part to a resident operating a commercial business (auto repair) from his home; and

WHEREAS, the installation of the requested signage will significantly improve the availability of on street parking for residents and their guest.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA as follows:

SECTION 1: Vehicles are prohibited from parking on Lynn Circle, SW from Lynn Drive, SW to Benjamin E. Mays Drive, SW from 9:00 a.m. to 1:00 a.m. Monday through Friday - with no parking restrictions on Saturday and Sunday.

SECTION 2: The Mayor or his designee (Department of Public Works) is authorized to install signage at the appropriate locations along the prohibited area.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith be and are hereby waived in this instance only.
