AMENDING THE 2014 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TEN THOUSAND FIVE HUNDRED DOLLARS AND NO CENTS (\$10,500.00) FOR THE PURPOSE OF PREPARING THE “2012 DOWNTOWN HISTORIC RESOURCES SURVEY, PHASE 1”; AND FOR OTHER PURPOSES.

WHEREAS, the Georgia Department of Natural Resources seeks applications from Certified Local Governments (CLG) for federal Historic Preservation Fund Grants to fund the preparation of historic resource surveys, National Register of Historic Places nominations, preservation planning projects, information and educational activities, and other historic preservation-related projects; and

WHEREAS, the Urban Design Commission, as a Certified Local Government and as part of the Department of Planning and Community Development, qualifies for such funding;

WHEREAS, as a matter of public policy the Urban Design Commission is charged with safeguarding the City’s historic, aesthetic, and cultural heritage; fostering civic pride in accomplishments of the past; enhancing the City’s attractions to tourists; and raising the level of community understanding and expectation for quality in the built environment; and

WHEREAS, Resolution 12-R-0072 authorized the Mayor or his designee, to apply for, accept and sign all grant agreements from the State of Georgia Department of Natural Resources for funding for a 2012 Historic Preservation Fund CLG Predevelopment grant; and

WHEREAS, the Commissioner of the Department of Planning and Community Development has duly applied for and the City of Atlanta has been awarded a matching Federal matching grant in the amount of Ten Thousand Five Hundred (\$10,500.00) for the preparation of the “Downtown Historic Resources Survey, Phase 1”; and

WHEREAS, the grant documentation specifies that the local matching share of the grant (40% of the total project cost) shall be provided by the Atlanta Downtown Improvement District and Portman Holdings, LLC through their own funding and in-kind services; the Office of Planning’s in-kind services; as well as in-kind contributions of student work from Georgia Tech and Georgia State University;

NOW THEREFORE THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:

Section 1: That the 2014 (Intergovernmental Grant Fund) Budget, Department of Planning, and Community Development, be and is hereby amended as follows:
