

**AN ORDINANCE BY COUNCILMEMBER FELICIA A. MOORE TO CREATE A TRUST ACCOUNT AND TO DEPOSIT INTO SAID ACCOUNT, \$703,595.11 WHICH IS THE BALANCE OF THE FUNDS SET ASIDE IN THE FY 2014 BUDGET IN ORDER TO CONDUCT THE 2013 CITY OF ATLANTA GENERAL ELECTION AND A CITY-WIDE GENERAL RUN-OFF ELECTION, IF NECESSARY; TO DESIGNATE SAID FUNDS AND ACCOUNT FOR THE USE OF ELECTION RELATED PURPOSES, THE CITY COUNCIL'S TECHNOLOGY RELATED NEEDS AND PURPOSES, AND FOR COMMUNICATION RELATED NEEDS AND PURPOSES; AND FOR OTHER PURPOSES.**

WHEREAS, the Fulton County Board of Registration and Elections (the Board) provided an initial quotation of \$2.4 million in order to conduct the 2013 city of Atlanta general election and a city-wide general run-off election, if necessary; and

WHEREAS, the Board subsequently revised that estimated cost to \$1,446,404.89; and

WHEREAS, the City included the initial amount in its FY 2014 budget, leaving a balance of \$953,595.11; and

WHEREAS, FY 2014 budget (#13-O-0619) Amendment #1, in the amount of \$250,000.00 was used to fund Channel 26 technical upgrades, thereby reducing the aforementioned balance to \$703,595.11; and

WHEREAS, the remaining funds should be deposited into a trust account to be used for any unanticipated and unexpected election needs and for any city council technology and communication related needs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, as follows:

Section 1: A trust account is hereby created for the purpose of depositing into said account, \$703,595.11 which is the balance of the funds set aside in the FY 2014 Budget in order to conduct the 2013 City of Atlanta general election and a city-wide general run-off election, if necessary and to designate said funds and account for the use of election related purposes, the city council's technology related needs and purposes, and for city council communication related needs and purposes.

Section 2: All ordinances and code sections or parts of ordinances and code sections in conflict herewith are hereby waived to the extent of any such conflict.
