WHEREAS, the Budget Commission of the City of Atlanta has recommended increasing estimated receipts in the 2013 (Community Development Fund) Budget by \$2,284,968.00 and the 2013 (HOME Investment Trust Fund) Budget by \$301,810.00.

THE COUNCIL OF THE CITY OF ATLANTA HEREBY ORDAINS AS FOLLOWS:
