**AN ORDINANCE BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE AMENDING THE 2013 INTERGOVERNMENTAL FUND BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS NEIGHBORHOOD STABILIZATION PROGRAM, PROGRAM INCOME IN THE AMOUNT OF THREE HUNDRED, TWO THOUSAND DOLLARS FIVE HUNDRED EIGHTY AND NO CENTS (\$302,580.00) FOR THE PURPOSE OF FUNDING THE NEIGHBORHOOD STABILIZATION PROGRAM; AND FOR OTHER PURPOSES**

WHEREAS, under Title III of Division B of the Housing and Economic Recovery Act, 2008 \$12.3 million has been appropriated to the City of Atlanta (“City”) to fund the CDBG Neighborhood Stabilization Program (“HUD NSP”) for emergency assistance for redevelopment of abandoned and foreclosed homes and residential properties; and

WHEREAS, the Georgia Department of Community Affairs (DCA) also has a CDBG Neighborhood Stabilization Program (“DCA NSP”) for emergency assistance for redevelopment of abandoned and foreclosed homes and residential properties; and

WHEREAS, under The Dodd-Frank Wall Street Reform and Consumer Protection Act of 2010 \$4.9 million has been appropriated to the City to fund the Third Round of the CDBG Neighborhood Stabilization Program (“HUD NSP3”) for emergency assistance for redevelopment of abandoned and foreclosed homes and residential properties; and

WHEREAS, the DCA NSP, HUD NSP and HUD NSP3 each generate program income; and

WHEREAS, the DCA NSP program income is recorded in accordance with Ordinance 11-O-1433 adopted by the Atlanta City Council November 7, 2011 and approved per City Charter Section 2-403 on November 16, 2011; HUD NSP program income is recorded in accordance with Ordinance 11-O-1268 adopted by Atlanta City Council on September 19, 2011 and approved per City Charter Section 2-403 on September 28, 2011; and HUD NSP3 program income is recorded in accordance with Ordinance 13-O-1125 adopted by Atlanta City Council on July 15, 2013 and approved per City Charter Section 2-403; and

WHEREAS, the City may use ten percent (10%) of program income received from DCA NSP, HUD NSP and HUD NSP3 for administrative costs associated with the implementation of the Neighborhood Stabilization Programs; and

WHEREAS, the City’s Department of Planning and Community Development (“DPCD”) desires to allocate ten percent (10%) of DCA NSP, HUD NSP and HUD NSP3 program income for administrative costs necessary to implement the Neighborhood Stabilization Programs; and

WHEREAS, the City desires to use the program income to fund additional DCA NSP and HUD NSP3

projects.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the DPCD is authorized to allocate ten percent (10%) of of DCA NSP, HUD NSP and HUD NSP3 program income for administrative costs necessary to implement the Neighborhood Stabilization Programs.

Section 2: That the 2013 Intergovernmental Fund Budget be and are hereby amended as follows:

**WHEREAS**, under Title III of Division B of the Housing and Economic Recovery Act, 2008 \$12.3 million has been appropriated to the City of Atlanta (“City”) to fund the CDBG Neighborhood Stabilization Program (“HUD NSP”) for emergency assistance for redevelopment of abandoned and foreclosed homes and residential properties; and

**WHEREAS**, the Georgia Department of Community Affairs (DCA) also has a CDBG Neighborhood Stabilization Program (“DCA NSP”) for emergency assistance for redevelopment of abandoned and foreclosed homes and residential properties; and

**WHEREAS**, the City may use ten percent (10%) of program income received from DCA NSP, HUD NSP and HUD NSP3 for administrative costs associated with the implementation of the Neighborhood Stabilization Programs; and

**WHEREAS**, the City’s Department of Planning and Community Development (“DPCD”) desires to allocate ten percent (10%) of DCA NSP, HUD NSP and HUD NSP3 program income for administrative costs necessary to implement the Neighborhood Stabilization Programs; and

**WHEREAS**, the City desires to use the program income to fund additional DCA NSP and HUD NSP3 projects.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1:** That the DPCD is authorized to allocate ten percent (10%) of of DCA NSP, HUD NSP and HUD NSP3 program income for administrative costs necessary to implement the Neighborhood Stabilization Programs.
