**AN ORDINANCE BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE  
AMENDING ATLANTA CODE OF ORDINANCES SECTION 110-59 (A) PROHIBITED CONDUCT,  
BY ADDING THE PROHIBITION OF OFF ROAD VEHICLES IN ALL CITY OF ATLANTA PARKS,  
TRAILS AND GREENSPACES; AND FOR OTHER PURPOSES.**

WHEREAS, the Atlanta Code of Ordinances (the “Code”) Section 110-59 Prohibited Conduct establishes conduct that is banned in City of Atlanta (“City”) parks; and

WHEREAS, for the safety of the public and park property, the Department of Parks and Recreation (“DPR”) desires to prohibit the use of off road vehicles in the public parks, trails and greenspaces to include all terrain vehicles and motorcycles (collectively referred to as “Vehicles”), except motorcycles that remain upon roadways laid out and maintained for vehicular travel as described in sections 110-87 and 110-88 of the Code; and

WHEREAS, the DPR desires to amend Section 110-59 (a) of the Code to prohibit the use of Vehicles in all City parks, trails and greenspaces.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: Atlanta Code of Ordinances Section 110-59 (a) entitled “Prohibited Conduct”, setting forth prohibited conduct in City parks, is hereby amended by adding a number 30 to the list of prohibitions which reads:

(30) Use of off road vehicles in the public parks, trails and greenspaces to include all terrain vehicles and motorcycles, except motorcycles that remain upon roadways laid out and maintained for vehicular travel as described in section 110-87 and 110-88.

SECTION 2: This Ordinance will take effect immediately upon approval.

SECTION 3: All ordinances and resolutions in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of said conflict.
