AN ORDINANCE BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE AMENDING THE 2014 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS A GRANT AWARD OF FIVE HUNDRED NINETY-TWO THOUSAND, TWO HUNDRED FIFTY-THREE DOLLARS (\$592,253.00) WITH NO MATCHING FUNDS, FROM THE 2013 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (“2013 JAG”) FROM THE UNITED STATES DEPARTMENT OF JUSTICE, BUREAU OF JUSTICE AFFAIRS (“DOJ”), FOR THE PURPOSE OF IMPROVING CRIMINAL JUSTICE IN THE CITY OF ATLANTA; AND FOR OTHER PURPOSES.

WHEREAS, the United States Department of Justice (“DOJ”) has, through the 2013 Edward Byrne Memorial Justice Assistance Grant Program, awarded the Atlanta Police Department and Fulton County Government a joint grant award totaling five hundred ninety-two thousand, two hundred fifty-three dollars (\$592,253); and

WHEREAS, the Department will receive the entire joint award and then pay to Fulton County their share of the joint award as agreed to in the attached Memorandum of Understanding approved by resolution 13-R-3315; and

WHEREAS, the pay-out to Fulton County for their share of the joint award is one hundred forty-eight thousand, sixty-three dollars and twenty-five cents (\$148,063.25), and the Atlanta Police Department will retain four-hundred forty-four thousand, one hundred eighty-nine dollars and seventy-five cents (\$444,189.75) to fund police initiatives; and for other purposes.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:
