

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE 13-O-1218, TO ADD 400 NORTHSIDE DRIVE, NW., AS AN ADDITIONAL ADDRESS TO LOCATIONS THAT ARE EXEMPT FROM THE PROHIBITION OF TEMPORARY USE PARKING LOT PERMITS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta has an interest in maintaining the health, safety and welfare of the citizens of the city of Atlanta and its visitors; and

WHEREAS, the City of Atlanta Charter provides that the City of Atlanta may regulate parking in the City of Atlanta Charter Section 1-102(c)(36); and

WHEREAS, Chapter 150, Article II, Section 150-26 permits the police chief with the concurrence of the Commissioner of Public Works to issue temporary 30 day off-street parking permits for use during athletic events or annual fairs; and

WHEREAS, unlike parking lots and parking garages operating in accordance with permits issued under Chapter 30, Article XVII, holders of permits issued in accordance with Section 150-26 are not permitted to provide monthly parking, or to operate without an attendant or cashier; and

WHEREAS, Ordinance 13-O-1218 adopted by the Atlanta City Council on September 3, 2013 and approved on September 12, 2013 amended Chapter 150, Article II, Section 150-26 in its entirety and with an effective date of eight months from the date of approval (the "Ordinance"); and

WHEREAS, Section 2 of the Ordinance listed addresses that are exempt from the prohibition of Temporary Use Parking Lot Permits; and

WHEREAS, it is the desire of the City of Atlanta to amend Section 2 of the Ordinance to add an additional address to locations that are exempt from the prohibition of Temporary Use Parking Lot Permits eight months after the Ordinance approval date.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Section 2 (2) of Ordinance 13-O-1218 which currently reads as follows:

(2) The English Avenue Neighborhood, described as the area bounded by Simpson Street, Northside Drive, North Avenue and Ashby Street with the exception of the property known as 505 Jones Avenue, N.W., Atlanta,

At the conclusion of eight months following the passage of this Ordinance, applicants may apply for Temporary Use Parking Lot Permits in the above listed areas.

Shall be replaced and shall now read as follows (additional language in bold):

(2) The English Avenue Neighborhood, described as the area bounded by Simpson Street, Northside Drive, North Avenue and Ashby Street with the exception of the property known as 505 Jones Avenue, N.W., Atlanta, Georgia 30318 (Parcel Identification Number 14-0082-0009-077-1).

At the conclusion of eight months following the passage of this Ordinance, applicants may apply for Temporary Use Parking Lot Permits in the above listed areas.

SECTION 2: This ordinance shall become effective eight months from the date of approval of ordinance 13-O-1218.

SECTION 3: All ordinances in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of said conflict.
