**TRANSFERRING FUNDS FROM THE DISTRICT FIVE (5) COUNCILMEMBER'S CARRY-FORWARD IN THE NON-DEPARTMENTAL TO THE DEPARTMENTS OF PUBLIC WORKS AND ATLANTA POLICE FOR VARIOUS PEDESTRIAN AND TRAFFIC CALMING MEASURES IN COUNCIL DISTRICT FIVE, IN THE AMOUNT OF \$\_\_\_\_\_ ; AND FOR OTHER PURPOSES.**

**WHEREAS**, the residents in District 5 of the city of Atlanta have sought to get sidewalks and curbing on their streets; and

**WHEREAS**, the installation of sidewalks and pedestrian ramps to assist those residents with disabilities have also been sought by in the district; and
