AN ORDINANCE COUNCILMEMBER MICHAEL JULIAN BOND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO REVISE EXISTING PARKING REGULATIONS ON ORMOND STREET, S.W., BILL LUCAS DRIVE, S.W. AND CREW STREET, S.W.; AND FOR OTHER PURPOSES.

WHEREAS, currently off-street parking availability is limited for visitors of 818 Pollard Boulevard, S.W. ("the facility") where the Atlanta Workforce Development Agency, Taxicabs for Hire and the future home of the Office of Code Enforcement is located; and

WHEREAS, when the Office of Code Enforcement is relocated to the facility, the parking area will be reserved for employees only with gated control access; and

WHEREAS, the Office of Enterprise and Asset Management ("OEAM") requested the Department of Public Works to assess possible on-street parking spaces near the facility; and

WHEREAS, the Department of Public Works conducted an assessment of on-street parking near the facility and determined the creation of some on-street parking spaces, by revising existing parking restrictions, will not impede normal traffic flow.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Mayor, or his designee, is authorized to remove parking restrictions along the north side of Ormond Street between Pollard Boulevard, S.W. and Hank Aaron Drive, S.E. except on the days of Atlanta Braves games at Turner Field.

SECTION 2: That parking restrictions along the south side of Ormond Street between Crew Street, S.W. and Hank Aaron Drive, S.E. be removed except on the days of Atlanta Braves games at Turner Field and except where a left turn lane onto Hank Aaron Drive, S.E. exists.

SECTION 3: That parking restrictions along the north side of Bill Lucas Drive, S.W. between Hank Aaron Drive, S.E. and Pollard Boulevard, S.W. be removed except on the days of Atlanta Braves games at Turner Field.

SECTION 4: That parking restrictions along the west side of Crew Street, S.W. between Little Street, S.W. and Bill Lucas Drive, S.W. be removed except on the days of Atlanta Braves games at Turner Field.

SECTION 5: That the Department of Public Works is authorized to implement necessary parking restrictions near driveways, intersections and fire hydrants along the aforementioned streets without requiring further legislation.

SECTION 6: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived only to the extent of the conflict.

SECTION 4: That parking restrictions along the west side of Crew Street, S.W. between Little Street, S.W. and Bill Lucas Drive, S.W. be removed except on the days of Atlanta Braves games at Turner Field.

SECTION 5: That the Department of Public Works is authorized to implement necessary parking restrictions near driveways, intersections and fire hydrants along the aforementioned streets without requiring further legislation.
