WHEREAS, the City of Atlanta (“City”) authorized FC-5035B, Annual Contract for the Disposal of Municipal Solid Waste (“Agreement”) with Republic Services of Georgia, LP, on behalf of the Department of Public Works and the Department of Watershed Management, pursuant to Ordinance 11-O-0324; and

WHEREAS, the term of the Agreement is for three (3) years with two (2) one (1) year renewal options to be exercised at the City’s sole discretion effective May 31, 2011 through May 30, 2014; and

WHEREAS, the Department of Watershed Management encumbered funds for Year One (1) of the Agreement in an amount not to exceed Three Million, One Hundred Twenty-Nine Thousand Dollars and Zero Cents (\$3,129,000.00); and

WHEREAS, the encumbrance was sufficient for Years One (1) and Two (2) of the Agreement only, the Department of Watershed Management desires to encumber Year Three (3) funding for the Agreement in an amount not to exceed Three Hundred Forty Thousand Dollars and No Cents (\$340,000.00); and

WHEREAS, Republic Services of Georgia, LP continues to satisfactorily perform services under the Agreement; and
