A RESOLUTION BY FINANCE/EXECUTIVE COMMITTEE A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY OF ATLANTA TO EXECUTE A CONTRACTUAL AGREEMENT FOR FC-6508, REVENUE RECOVERY SERVICES, ON BEHALF OF THE DEPARTMENT OF FINANCE – OFFICE OF REVENUE WITH PRA GOVERNMENT SERVICES, LLC, D/B/A RDS, TO PROVIDE FULL REVENUE RECOVERY SERVICES; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the “City”) solicited Requests for Proposals for FC-6508 Revenue Recovery Services on behalf of the Department of Finance Office of Revenue to provide full revenue recovery services for the City; and

WHEREAS, PRA Government Services, LLC, doing business as RDS, was the sole respondent and was deemed responsive to the request for proposals for FC-6508; and

WHEREAS, the revenue recovery services shall consist of all or any combination of identifying and collecting of unpaid taxes and/or fees from unregistered and undocumented businesses and individuals discovered to owe revenue to the City by virtue of non-compliance with state and local regulations to operate a business within the city’s limits; and

WHEREAS, upon recommendation of the City’s Chief Financial Officer and the Chief Procurement Officer, the City desires to enter into an agreement with PRA Government Services, LLC, for revenue recovery services with an initial term of three (3) years with two (2) one-year renewal options at the sole discretion of the City (the “Agreement”); and

WHEREAS, the compensation for the Agreement will be based on a rate of thirty percent (30%) of the revenue collected, excluding any penalties, accrued interest and late fees as applicable as in Exhibit A-1 attached.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES, that the Mayor or his designee is authorized to enter into the Agreement with PRA Government Services, LLC, d.b.a. RDS to provide full recovery services for FC-6508 Revenue Recovery Services on behalf of the Department of Finance in substantially the form attached as Exhibit A.

BE IT FURTHER RESOLVED, that the compensation for the Agreement will be based on a rate of thirty percent (30%) of the revenue collected, excluding any penalties, accrued interest and late fees as applicable and the Agreement shall have an initial term of three (3) years with two (2) one-year renewal options at the sole discretion of the City.

BE IT FURTHER RESOLVED, that the proceeds from the Agreement will be deposited to various Fund Department Organization Accounts representing various types of City revenue.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer is directed to prepare an appropriate agreement for execution by the Mayor or his designee.

BE IT FURTHER RESOLVED, that the Agreement will not become binding on the City and the City will incur no obligation or liability under it until it has been approved as to form by the City Attorney,

executed by the Mayor, attested to by the Municipal Clerk and delivered to PRA Government Services, LLC.
