CITY OF ATLANTA, CIVIL ACTION FILE NO. 2012-CV-212212, FULTON COUNTY SUPERIOR COURT, IN THE AMOUNT OF \$30,000.00; AUTHORIZING SAID AMOUNT TO BE PAID FROM FUND 1001 (GENERAL FUND) CENTER NUMBER 200101 (NON DEPARTMENTAL) ACCOUNT 5212005 (LITIGATION EXPENSES) AND 1512000 (ACCOUNTING); AUTHORIZING THE CHIEF FINANCIAL OFFICER TO DISTRIBUTE THE TOTAL SETTLEMENT AMOUNT; AND FOR OTHER PURPOSES.

WHEREAS, Plaintiff E. A. Gibbons Consulting, LLC filed a lawsuit, *E. A. Gibbons Consulting, LLC vs. City of Atlanta*, alleging that its property was damaged as result of storm water flooding onto the property;

WHEREAS, Plaintiff alleges that due to failure and inadequacies of the City of Atlanta's storm water drainage system, its property sustained damages resulting from storm water flooding;

WHEREAS, the City Attorney has done extensive review of the facts and the law, and has determined that the City of Atlanta's potential financial exposure in defending Plaintiff's claims is in excess of the settlement amount;

WHEREAS, Plaintiff E. A. Gibbons Consulting, LLC, has agreed to accept \$30,000.00 in full settlement of all claims against the City of Atlanta including interest and attorney's fees;

WHEREAS, the City Attorney considers it to be in the best interest of the City to pay Plaintiff the total amount of \$30,000.00 to settle all claims against the City of Atlanta.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA hereby resolves as follows:

SECTION 1: The City Attorney is hereby authorized to settle and execute all settlement documents in the case of *E. A. Gibbons Consulting, LLC vs. City of Atlanta*, Fulton County Superior Court, Civil Action File No. 2012-CV-212212, in the amount of Thirty Thousand Dollars (\$30,000.00).

SECTION 2: The Chief Financial Officer is authorized to pay the amount of Thirty Thousand Dollars (\$30,000.00) to E. A. Gibbons Consulting, LLC. Said payment is to be charged, paid and issued from Fund 1001 (General Fund) Center Number 200101 (Non Departmental) Account 5212005 (Litigation Expenses) and 1512000 (Accounting); and made payable to *Martin & Jones, as attorneys for E. A. Gibbons Consulting, LLC*, 3353 Peachtree Road, Suite 510, Atlanta, Georgia 30326. Such payment shall be in full consideration of the dismissal of all claims against the City of Atlanta, and its current and former officers and employees.
