WHEREAS, the City of Atlanta ("City") did solicit Bids for Contract Number FC-5035, Annual Contract for the Disposal of Municipal Solid Waste ("Contract") on behalf of the Department of Public Works and the Department of Watershed Management; and

WHEREAS, the Atlanta City Council adopted Ordinance 11-0-0325 on March 21, 2011 and the same was approved per City Charter Section 2-403 on March 30, 2011 in an amount not to exceed Three Million Four Hundred Forty Six Thousand Seven Hundred Sixteen Dollars and No Cents (\$3,446,716.00) which authorized the Contract with Georgia Waste Systems, Inc., d.b.a. Waste Management of Atlanta; and

WHEREAS, the base term of the Contract is for a period of Three (3) years, with Two (2) One (1) year renewal options to be exercised at the sole discretion of the City effective May 31, 2011 through May 30, 2014; and

WHEREAS, the Resolution 12-R-1539 to enter into Amendment Number 1 with Waste Management of Atlanta for FC-5035A was filed by the City Council on November 19, 2012 on behalf of the Department of Public Works; and

WHEREAS, the Department of Public Works desires to enter into Amendment Agreement Number 1 with Georgia Waste Systems, Inc., d.b.a. Waste Management of Atlanta, for FC5035A, Annual Contract for the Disposal of Municipal Solid Waste, in an amount not to exceed Two Million Dollars and No Cents (\$2,000,000.00); and

WHEREAS, Georgia Waste Systems, Inc., d.b.a. Waste Management of Atlanta, has performed the contracted services satisfactorily; and

WHEREAS, the Commissioner of the Department of Public Works and the Chief Procurement Officer recommend this Amendment Agreement Number 1, Annual Contract for the Disposal of Municipal Solid Waste.
