

**AN ORDINANCE

AS SUBSTITUTED BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES
COMMITTEE**

AN ORDINANCE TO TRANSFER THE AMOUNT OF \$250.00 FROM EACH OF THE FIFTEEN (15) COUNCIL MEMBER AND COUNCIL PRESIDENT EXPENSE ACCOUNTS TO PURCHASE PERSONALIZED TILES IN SUPPORT OF THE "BUILD A FOUNDATION FOR THE FUTURE" TILE PROGRAM LAUNCHED BY THE NATIONAL CENTER FOR CIVIL AND HUMAN RIGHTS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta, the incubator for the Civil Rights Movement, is the home to the proposed National Center for Civil and Human Rights, a museum and cultural/research institution to present the American Civil Rights Movement and the contemporary human rights movements; and

WHEREAS, the Center will provide a forum to promote education, dialogue, and awareness of current and historic struggle for freedom and equality; and

WHEREAS, the Center will also be a catalyst for ongoing civil and human rights conversations at the local, national and international level; and

WHEREAS, in preparation for the grand opening scheduled for May 22, 2014, the National Center for Civil and Human Rights has launched the "Build A Foundation for the Future" Tile Program to provide the Atlanta City Council and other supporters the opportunity to purchase personalized tiles with a minimum donation amount (\$250.00 per tile); and

WHEREAS, tiles purchased by the council will be mounted with their names and districts listed and will be placed on permanent display within the designated section of the lobby of the Center; and

WHEREAS, the Atlanta City Council supports the Center and wishes to participate in the Tile Program by purchasing personalized tiles.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is hereby authorized to create an account and to remit payment to the National Center for Civil and Human Rights in the amount of \$4,000.00 to go towards the purchase of 16 personalized tiles (\$250.00 per tile) to be mounted on permanent display in the Center Lobby.

SECTION 2: That all payments shall be charged to and made from the followings:
