AS SUBSTITUTED BY FINANCE./EXECUTIVE COMMITTEE

AMENDING THE FISCAL YEAR 2014 (GENERAL FUND) BUDGET IN THE AMOUNT OF \$31,124.58 TO TRANSFER RESIDUAL COUNCIL MEMBER CARRY FORWARD BALANCES FROM AT LARGE POST 2 AND 3; AND FOR OTHER PURPOSES.

WHEREAS, during each City Council term, Council Members are allowed to carry forward appropriation balances that are unspent in their respective Council offices; and

WHEREAS, at the end of the Council terms Carry Forward balances, which are maintained in Non Departmental Reserves, continue to roll forward for returning Council Members but amounts held for non returning Members are returned to the General Fund to be used for other purposes; and

WHEREAS, as a result of the recent election held in November of 2013, the Council Post 2 and 3 will have new representation, Carry Forward balances will not be maintained for those offices for the remainder of the 2014 Fiscal Year; and

WHEREAS, Post 2 at Large closed out the Council term with an uncommitted and unencumbered balance of \$3,833.40; and

WHEREAS, Post 3 at Large closed out the Council term with an uncommitted and unencumbered balance of \$43,246.56, of which \$15,955.38 will be used to restore the operating budget for that Council office to levels reflecting six months of appropriations, leaving a balance of \$27,291.18; and

WHEREAS, it has been determined that remaining Carry Forward balances in Post 2 and 3 totaling \$31,124.58, should be transferred to City Council Shared Support, in the event that there are unknown expenses outstanding or to be available for various unforeseen operational or capital needs of the Atlanta City Council during the remainder of the 2014 Fiscal Year.



NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1: That the Fiscal 2014 (General Fund) Budget is hereby amended as follows:
