AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO ACCEPT A GRANT IN THE AMOUNT OF ONE MILLION SIX HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED SIXTY-EIGHT DOLLARS (\$1,628,268.00) FROM THE GEORGIA GOVERNOR'S OFFICE OF WORKFORCE DEVELOPMENT; AMENDING THE FY2014 (JOB TRAINING GRANT FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ONE MILLION SIX HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED SIXTY-EIGHT DOLLARS (\$1,628,268.00) IN THE WORKFORCE INVESTMENT ACT VIA ADULT WORKER FUND FROM THE GEORGIA GOVERNOR'S OFFICE OF WORKFORCE DEVELOPMENT, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO LOCAL ADULTS; AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the Workforce Investment Act ("WIA") is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the attainment of occupations skill for participants, thereby improving the quality of the workforce; and

WHEREAS, the Georgia Governor's Office of Workforce Development ("GOWD") has awarded the City of Atlanta ("City"), through the Atlanta Workforce Development Agency ("AWDA"), a grant in the amount of **ONE MILLION SIX HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED SIXTY-EIGHT DOLLARS (\$1,628,268.00)**, to provide job training funds for ADULTs who need to upgrade or acquire skills to obtain full-time employment at livable wages; and

WHEREAS, AWDA recommends the City to accept the WIA ADULTs Program FY 2014 grant to support its initiative in assisting ADULTs with job training and employment assistance; and

WHEREAS, AWDA recommends increasing receipts in the 2014 (Job Training Grant Fund) budget by **ONE MILLION SIX HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED SIXTY-EIGHT DOLLARS (\$1,628,268.00)** in the WIA ADULT fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: The Mayor or his designee, on behalf of the City of Atlanta, is authorized to accept a grant in the amount of **ONE MILLION SIX HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED SIXTY-EIGHT DOLLARS (\$1,628,268.00)** from GOWD for the purpose of aiding ADULTs with job training and employment assistance; and

Section 2: That the 2014 (Job Training Grant Fund) budget is hereby amended as follows:


