**A SUBSTITUTE ORDINANCE

**AN ORDINANCE TO FILE PENDING LEGISLATION HELD IN  
ZONING COMMITTEE AT THE END OF LAST YEAR; AND FOR  
OTHER PURPOSES.**

**WHEREAS**, pursuant to Section 2-407, entitled "Quadrennial relegation of pending legislation", under Chapter 4. Procedure of Council, Article 2 of the City Charter, all pending legislation held in committee following the general election, and on a quadrennial basis, will be automatically terminated at the end of the last city council meeting in December of that year, without any action by the city council and that the Municipal Clerk shall be authorized to file any legislation subject to this provision; and

**WHEREAS**, ten pieces of pending Zoning legislation were not filed by the Municipal Clerk at the end of the last city council meeting because they were not published on the last Full Council Agenda; and

**WHEREAS**, these papers were not on the last Full Council Agenda because they were referred to and were pending before the Zoning Review Board; and

**WHEREAS**, the ten pieces of pending Zoning legislation are identified as 11-O-1354, 12-O-0369, 12-O-0849, 12-O-1433, 13-O-1086, 13-O-1224, 13-O-1226, 13-O-1259, 13-O-1287, 13-O-1288, 13-O-1289, 13-O-1293, 13-O-1309, 13-O-1311, 13-O-1319, 13-O-1331, 13-O-1363, 13-O-1364, 13-O-1365, and 13-O-1399; and


**WHEREAS**, the Municipal Clerk Office has now requested legislation to properly file said legislation.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
ATLANTA, GEORGIA, as follows:**
