**AN ORDINANCE BY
COUNCILMEMBER KEISHA LANCE BOTTOMS**

AN ORDINANCE AUTHORIZING PAYMENT TO CRIME STOPPERS ATLANTA IN THE AMOUNT OF TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00), FROM THE DISTRICT 11 COUNCILMEMBER CARRY FORWARD IN THE NON-DEPARTMENTAL RESERVES, FOR INFORMATION LEADING TO THE ARREST OF INDIVIDUALS INVOLVED IN THE MURDER OF JORDAN ASHLEY; AND FOR OTHER PURPOSES.

WHEREAS, on August 23, 2012, Jordan "Timmy" Ashley was walking home from Danforth Road in Southwest Atlanta where he was robbed and murdered; and

WHEREAS, Jordan worked at Atlanta Hartsfield-Jackson International Airport on, volunteered at the Georgia Aquarium, and was to enroll at Georgia State University in January 2013 to pursue his dream of becoming a marine biologist; and

WHEREAS, to date, the perpetrators of this crime have not been arrested; and

WHEREAS, in an effort to facilitate the solving of this crime, the District 11 Council Member is seeking authorization to contribute Two Thousand Five Hundred (\$2,500.00) to Crime Stoppers Atlanta for information leading to the arrest of individuals involved in the murder of Jordan Ashley.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized, upon receipt of proper documentation, to remit payment to Crime Stoppers Atlanta in the amount of Two Thousand Five Hundred Dollars (\$2,500.00).

SECTION 2: That all payments shall be charged to and paid from the following:
