A RESOLUTION AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO ENTER INTO RENEWAL AGREEMENT NUMBER 2 WITH CIVIL WORKS, INC., FOR FC-5272B, ANNUAL CONTRACT FOR EMERGENCY ON CALL SERVICES, ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS FOR TIME ONLY; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") did solicit Bids for Contract No. FC-5272, Annual Contract for Emergency On Call Services; and

WHEREAS, the Atlanta City Council adopted Resolution 11-R-1536 on November 7, 2011 and the same was approved as per City Charter Section 2-403 on November 16, 2011, which authorized the Agreement for FC-5272B with Civil Works, Inc.; and

WHEREAS, the base term of the Contract was for a period of one (1) year, with two (2) one (1) year renewal options to be exercised at the sole discretion of the City effective February 14, 2012 through February 13, 2013; and

WHEREAS, the Atlanta City Council adopted Resolution 13-R-0185 on February 18, 2013 and the same was approved as per City Charter Section 2-403 on February 25, 2013 which allowed the Department of Public Works to enter into Renewal Agreement Number 1 with Civil Works, Inc. effective February 14, 2013 through February 13, 2014; and

WHEREAS, the Department of Public Works desires to enter into Renewal Agreement Number 2 with Civil Works, Inc., for FC-5272B, Annual Contract for Emergency On Call Services; and

WHEREAS, Civil Works, Inc. has performed the contracted services satisfactorily; and

WHEREAS, the Commissioner of the Department of Public Works and the Chief Procurement Officer recommend this Renewal Agreement Number 2 for FC-5272B, Annual Contract for Emergency On Call Services.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES that the Mayor, or his designee, is authorized to execute Renewal Agreement Number 2, with Civil Works, Inc. for FC-5272B, Annual Contract for Emergency On Call Services, on behalf of the Department of Public Works for time only.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer is directed to assist the City Attorney in the preparation of the appropriate Agreement for execution by the Mayor.

BE IT FINALLY RESOLVED, that the Agreement will not become binding upon the City, and the City will incur no liability under it until the Agreement has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk, and delivered to Civil Works, Inc.
